



## PLAR Application Checklist

Prospective HIM students may apply for a Prior Learning Assessment and Recognition (PLAR). This review allows an assessor to determine whether previous academic and work experience matches courses or practicums in the HIM curriculum. Prospective students may apply for recognition and exemption from any course or practicum offered within the HIM program. It is at the discretion of CHA Learning to grant exemptions based on the information submitted by the student.

Additionally, applicants who do not meet the healthcare professional experience requirement may request to have their post-secondary education and their professional work experience considered. It is at the discretion of CHA Learning to grant exemptions based on the information provided by the student.

Applicants seeking work-related practicum exemptions will need to provide both detailed work descriptions and a letter of attestation from their employer. It is at the discretion of CHA Learning to grant exemptions based on the information provided by the student.

## Course Exemptions Checklist:

PLAR applications must include all the components listed in the HIM Application Checklist, and the PLAR Application Checklist. CHA Learning does not accept incomplete applications. PLAR applications take up to 2 weeks to review.
